Set up MUST BE COMPLETED by 10am, Saturday, October 2, 2021, and take down must not be before 5pm on Sunday, October 3, 2021.

Park security will be provided Saturday night, however, losses will be the vendor responsibility.

Checks/money orders should be made out to the OSWEGO YMCA with a certificate of insurance naming the City of Oswego AND the Oswego YMCA as additional insured. Fees are not transferrable and non-refundable. Sales tax registration certificate must be displayed.
